⇒ For learners with legal residence in the Canton of Zug:

The costs for school operations such as infrastructure and staff are covered by the canton of Zug.

For further costs and expenses, a personal contribution will be charged to the learners of the bridging programs of the canton of Zug:

Personal contribution for teaching materials, consumables, photocopies, excursions and project weeks: **CHF 1'100.00 annual contribution** (invoicing: start of school CHF 550.00 / 2nd semester CHF 550.00)

K-B-A

Personal contribution for teaching materials, consumables, photocopies, excursions and outdoor days: **CHF 450.00 annual contribution** (invoicing: start of school CHF 450.00)

I-B-A

Personal contribution for teaching materials, consumables, photocopies, TELC test fee (language test), excursions, camps and project weeks:

CHF 950.00 annual contribution (invoicing: start of school CHF 400.00 / 2nd semester CHF 550.00)

* The billing is issued to the learners upon reaching adulthood. For learners under 18 years of age, the invoice is sent to the legal guardians.

⇒ For learners with <u>residence outside the canton of Zug</u>:

In addition to the costs listed above for teaching materials, consumables, photocopies, excursions and project weeks, the costs of running the school, such as infrastructure and staff, must also be borne by the parents/legal guardians. The annual contribution is based on the Annex to the Intercantonal Agreement on Contributions to Training Costs in Vocational Education and Training (Vocational School Agreement, BFSV*). The contributions are redefined annually.

I-B-A-20+ Integration bridging program for adults

⇒ For learners with <u>legal residence in the Canton of Zug</u>:

The I-B-A-20+ is subsidized by the Canton of Zug.

The Participants bear part of the costs themselves. The price for 4 months (1 trimester) is CHF 1'160.00.

The amount will be invoiced during the first month of the current trimester.

Attendance at the I-B-A-20+ is limited to a maximum of 3 trimesters. The maximum cost for an entire year of the program is therefore CHF 3'480.00.

If participants attend external, paid courses due to their personal goals, they can deduct up to CHF 400.00 per trimester (or CHF 100.00 per month) from the contribution upon providing proof of payment.

Further reductions, cuts, or refunds of the contributions due to hardship cases may be approved by the program management.

The admission and information interview are free of charge.

Career orientation year

The bridging programs of the Canton of Zug can cover the costs of a career orientation year for five young people in the following order of priority:

1. Priority 1:

Young people with a **learning disability** (according to the internationally recognized statistical classification of diseases and related health problems [ICD-10]: code F.81.3) and/or persistent learning goal adjustments in several subjects.

2. Priority 2:

Young people with multiple impairments due to a diagnosed autism spectrum disorder or higher support requirements (1:1 guidance) identified by the school psychiatric service or special support needs identified by the special education teacher, and who have unsatisfactory grades in several subjects

The costs for young people with legal residence in the Canton of Zug are covered by the public authorities.

A personal contribution of CHF 1,500.00* (annual fee) corresponds to the costs specified in the regulations for bridging programs at secondary II schools. The amount will be collected directly by the provider.

*Admission requirement:

The legal guardians confirm that they will pay the contribution of CHF 1,500.00 for school events and material costs.
